Deadline Information:

- All completed entries are required to be received by August 1, 2014. Artists will be notified by e-mail no later than August 5, 2014

Auburn Art Walk Requirements:

- All artwork exhibited must be created by, or under the direction of the artist. Artwork exhibited during the Art Walk must be consistent with images reviewed and accepted during the jury process. An artist may not sell or exhibit artwork of non-juried artists. No forms of mass produced products are permitted with the exception of prints or cards from the artist's own work. The artist who submitted and was accepted into the Art Walk must be present. Please do not send a representative in your place.
- Artist must provide their own display materials including chairs, tables, easels, pedestals, portable walls etc... . There will be limited wall space available. Please note on the application your display requirements so we can best match you with one of our business partners.
- Attendance is required at the Artist orientation scheduled for the evening of August 19, 2014 at 6:00PM. Artists will be advised of their business partner at this meeting.
- Careful consideration is made when matching Artists with businesses but it is the Artists responsibility to meet with their assigned business prior to the Art Walk to review the space being made available by the business and confirm install and removal times.
- Artists selling their work will be responsible for payment of any state, city or local sales taxes due to the appropriate agency.
- Artists are allowed to accept payment in any form that they wish. If you wish to accept credit cards, you must have the means to do so. The business that you are partnered with will not be providing any type of credit card processing for you.
