## STEP 1: CONTACT THE STATE AND THE DEPARTMENT OF REVENUE

## Washington State Department of Social and Health Services (DSHS)

Complete a DSHS application for an Adult Family Home. State requirements and their application can be found at:

## Washington State Department of Revenue (DOR)

Obtain a Unified Business Identifier (UBI) number from the WA Department of Revenue. This is for a State Business License.

<u>https://dor.wa.gov/doing-business/register-my-business</u> At the same time you can apply for the city license/endorsement at the same site.

### STEP 2: APPLY FOR A CITY ENDORSEMENT/LICENSE THROUGH THE STATE BLS PORTAL

Apply for an endorsement/business license through the State BLS web portal

Select this link. https://dor.wa.gov/doing-business/register- my-business

The application and data will be forwarded to the city for review.

(Please note page 2 of the application does not apply)



A floor plan is required. Client bedrooms shall be lettered as A, B, C, D, E, F, etc... Include the square footage and number of beds per room. This information must be provided to prevent rejection of your application.

## **STEP 3: PAY FEES**

The cost of the home-based Auburn license/endorsement through the state is \$103., collected through the state endorsement.

The cost for a City of Auburn Home Occupation license is \$103.00 and for the inspection \$361.00.


### STEP 4: SCHEDULE A CITY INSPECTION

To schedule an Adult Family Home Inspection please have ready:

1. WABO checklist: https://www.dshs.wa.gov/altsa/residential-care-services/afh-building-inspections



## 2. Floor plan:



The inspector will contact you directly to schedule your inspection. Inspections can also be requested by emailing:

inspections@auburnwa.gov

During inspection the inspector will review the WABO checklist items with you. Upon completion of the inspection and correction of any items pertaining to the WABO checklist are made, the inspector will return the checklist to the Business license department for processing.

The WABO checklist will be scanned for retention with the final approval signature of the inspector. A copy will be maintained and become part of your DSHS Application Packet.

## **STEP 5: COMPLETE THE PROCESS**

- Submit the approved WABO Inspection checklist to the State of Washington DSHS to complete your Adult Family Home Application.

- 2. Once the State DSHS office **issues** the Adult Family Home License, email a copy to the City for final review and approval of your Auburn Business License. businesslicenses@auburnwa.gov

### **STEP 6: RENEW ANNUALLY**



## □ Building Plans

Please note that a final building inspection is required <u>PRIOR</u> to issuance of a City of Auburn Business License/city endorsement from the state for any new or remodeled Adult Family homes.
