		1.	Applicant has a valid Wireless Franchise Agreement with the City of Auburn.			
			Approval of this application may be subject to approvals for construction, building, land use,			
		2.	environmental, lease or license agreements, and any other permits or approvals as required by applicable City, State and Federal regulations.			
		3.	Applicant is responsible for determining whether or not the scope of the proposed project and sites requires any land use, planning, building, or environmental reviews and approvals and submitting the required complete applications concurrently so that the City can review all required permits within the required Federal regulation timelines.			
		4.	Applications expire 180 days from inactivity as determined by the City if a permit is not issued. If the application expires, Applicant must submit a new Small Wireless Facilities Application.			
		5.	Permits for siting or construction expire 180 days after permit issuance if applicant fails to build or otherwise install the approved facilities and equipment. If the permit expires Applicant must submit a new Small Wireless Facilities Application.			
		6.	Application fees are due with submittal of the application and are non-refundable and non-transferrable. Any new application will require a new application fee. Applications will not be determined to be complete until the full application fee is received by the City.			
		7.	Failure to timely satisfy all requirements of Chapter 20.14 of the Auburn City Code including meeting the Engineering Design and Construction Standards requirements related to small wireless facilities will result in a denial of the permit.			
		8.	An application will be deemed incomplete if any application information required under Auburn City Code 20.14.020 is not provided.

Approval of any portion of this application will be contingent upon approval of a franchise under ACC 20.04 and a license under ACC 20.08 if applicable. Review of this application will comply with all applicable City, state and federal regulations. Applicant may apply for up to five sites in this one application.

- A. Specific location information including GPS coordinates of all proposed facilities.
- B. Specific design and construction information and plans, addressing poles or other support structures, attachments, conduits, and any ground-mounted equipment meeting all City of Auburn Engineering Design and Construction Standards requirements. Plan preparation and format is required to conform to the City of Auburn Engineering Design Standards Chapter 3 and will include a site specific traffic control plan as well as a site specific pedestrian detour plan for working in the right-of-way. Traffic control and pedestrian detour plans will be reviewed to accommodate non-peak public usage for both lane closure restrictions and pedestrian access.

C. A narrative addressing how the proposed plans are consistent with the franchise exhibits(s), if applicable, or otherwise meet the design requirements of this chapter, and otherwise as required within the ACC. D. A concealment plan demonstrating how the proposed small wireless facilities comply with the City of Auburn Engineering Design and Construction Standards. Plan preparation and format shall conform to the City of Auburn Engineering Design Standards Chapter 3. E. Provision of proof of Federal Communications Commission, FAA, and other regulatory approvals required to provide the service(s) or use the technologies sought to be installed. F. Provision of proof that the proposed facilities will not interfere with the City's automated meter (AMI), telemetry (SCADA), automated light meter facilities, or other City communication facilities. Provide the frequencies used by the proposed equipment authorized by the FCC for E. above and documentation certifying non-interference of frequencies used by the applicant with frequencies used by the City. G. Provision of proof from pole or structure owners that the additional load of small wireless facilities can be accommodated by the poles or structures. H. Any other information determined by the Director to be necessary for processing the application. 1. Provide a network map showing this facilities interconnection with any other small wireless facilities installations. other wireless facilities, fiber, microwave, or any other telecommunications facility, equipment, or installation whether or not it is owned, operated, or otherwise under the control of the applicant. Include sufficient detail to identify the location of the interconnected facilities and type of facilities. 2. If interconnected facilities in item 1. above are owned, operated or otherwise under the control of an entity or person other than the applicant, provide their complete contact information, including company name, address, phone number, e-mail, and contact person or office/department. 3. If co-location is proposed, provide all contact information for all other existing users of the proposed co-location facility, pole, structure or base station. 4. Will the proposed facilities allow any other entity to provide services to its customers? If yes, provide complete contact information including company name, address, phone number, e-mail, and contact person or office/department. 5. Will any portion of the proposed facilities, including ground equipment, conduit, or other appurtenances be located on private property? If yes, clearly show on the plans associated with this application and provide copies of recorded easements. Additional review and permitting may be required.

6. If the applicant is requesting a deviation from standards, the applicant must submit the application and

justification in compliance with the Engineering Design and Construction Standards.

### Required Application Information for each site per ACC 20.14.030

- A. Issuance of a small wireless facilities permit to install small wireless facilities will be contingent upon approval of a franchise under ACC 20.04 or the possession of a valid franchise. Please provide a valid franchise number and the effective date of the franchise.
- B. Applicant to indicate if any element of deployment qualifies as an eligible facilities request under 47 U.S.C. § 1455. These may be addressed separately by the Director in order to comply with the shot clocks established by federal law
- C. If any element of the proposal is not exempt from SEPA review, applicant will simultaneously submit a SEPA Environmental Checklist under Chapter 43.21C RCW and ACC 16.06 or provide the date of submittal if previously submitted. Proposals in critical areas, shorelines or new poles within a residential area will require submittal. For a full list of SEPA exemptions please see WAC 197-11-800. (There is a separate fee and application for SEPA checklist review).
- D. Applicant will provide the City with information on the projected power density of the facility and compliance with the FCC requirements.

#### Required Application Information for each site per ACC 20.14.060

- A. Submit written approval of the owner of any pole or structure for the installation of proposed facilities on such pole or structure.
- B. For use of City-owned poles in the public right-of-way or City-owned property, including the use of ground space, base station, or any other infrastructure in the public right-of way, provide proof of a valid License Agreement with the City with the Agreement number and date signed or when the agreement is anticipated to be completed if it is being processed concurrently.
