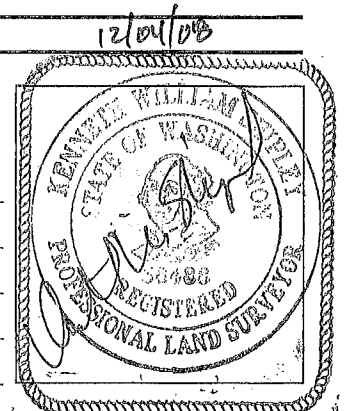

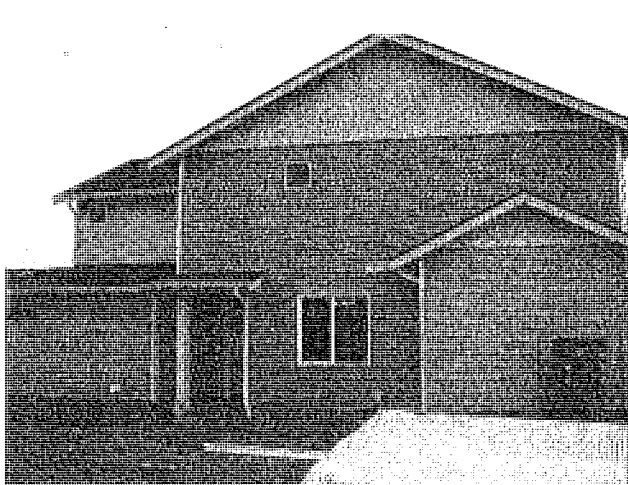

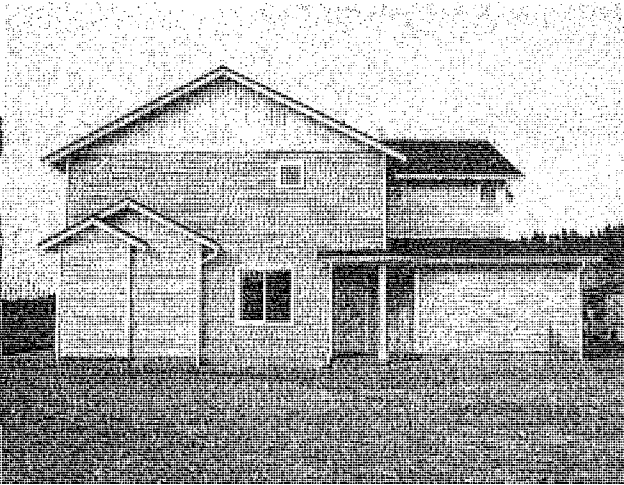
Rear View
