Entries on Display Until: Monday, December 16, 2019 at noon

Location: Auburn Community & Event Center; 910 Ninth Street SE, Auburn WA 98002

FREE entry open to all community groups, individuals, families, non-profits & businesses.

ADULT ENTRIES: Only ten (10) entries in the adult category will be accepted. You will be notified if you are accepted into the contest.

CHILD ENTRIES: Only eight (8) entries in the child category will be accepted. You will be notified if you are accepted into the contest.

Gingerbread House Contest Rules:

- Entry must be appropriate for audiences of all ages
- Entry must be original and built in 2019
- Entry must be 90% edible on the exterior
- Any Structure - real or imaginary is eligible for entry i.e. house, train, igloo, spaceship, etc.
- Adult category is ages 13 and up
- Child category is ages 12 and under - if selecting the child category the child must construct 100% of the structure. If an adult is helping then they must apply for the Adult category
- All entries must be brought to the Community & Event Center, December 2 between 8 AM and 9 PM. *Arrangements can be made with coordinator if necessary.*
- Adult category entries must be delivered in completed form attached to a solid base enabling it to be displayed on a table. Bases shall be no larger than 24"W x 24"L
- Child category entries must be delivered in completed form attached to a solid base enabling it to be displayed in a display case. Entries shall be no larger than 12"W x 12"L x 12"H
- Entries will be voted on by the general public
- Votes will be accepted at the Community & Event Center from December 2 - December 16 at noon
- Winner will receive a \$50 gift card
- All entries must be picked up by Friday, December 20 by 9 PM. Any entries remaining will be discarded
- The City of Auburn reserves the right to remove any entry from display at any time, for any reason, and at its sole discretion
