

# Auburn Parks, Arts & Recreation Petpalooza 2019 General Vendor Application Deadline: April 5, 2019



## About Auburn's Petpalooza

**Date:** Saturday, May 18, 2019

**Time:** 10:00 a.m. – 5:00 p.m.

**Location:** Game Farm Park, 3030 R Street SE

**Event profile:** An event for pet lovers and a special day for your four-legged family member or other furry friend. The event kicks off with the 9:30 a.m. Dog Trot Fun Run. The event, free to attendees, also includes live entertainment, frisbee dog activities, a petting zoo, the 'Unleashed' pet contest, an agility area, adoptions, vaccinations and other services, inflatable rides and childrens' activities, over 150 vendor booths, give-a-ways and lots of activities to keep both humans and pets entertained.

**Anticipated event attendance:** 16,000+

## Selection Criteria and Booth Information:

- Booths are uncovered 12' x 12' space (activity vendors may be granted additional space). Vendors must supply their own materials (canopies, tables, electrical cords, signs, etc.) and are responsible for all set-up and take-down. Vendors are required to stay in their assigned space and required to stay for the duration of the festival.
- Payment must accompany application. Unapproved applications and payments will be returned to you.
- Any vendor that has animals on-site (for display or adoption) must provide the City of Auburn with a copy of their liability insurance. Accepted activity vendors (and those required vendors) must provide proof of insurance, by April 30, 2019 for one million (\$1,000,000) dollars naming the City of Auburn as additional insured.
- Artists must submit photographs or images of your work. Include a self-addressed stamped envelope if you want photographs returned.
- Electricity is available on a limited basis (see below for fee structure). Payment must accompany application. If you're bringing your own source of temporary power, you're required to obtain and L&I Permit and schedule your inspection. Please contact L&I directly at 206-835-1000.
- The City of Auburn does not require a percentage of sales. Vendors keep all of their revenue.
- No refunds after the early application deadline of April 5, 2019. Prior to the deadline, refund will be given less \$5.
- Complete event information will be **e-mailed** the week of May 1.

## General Vendor Definitions and Fees

<b>Non-Profit/Rescue Vendor or Animal Club:</b> Any pet-related, non-profit agency or club. Non-profit certificate must accompany application form to receive non-profit rate. Vendors in this category are limited to no more than two booth spaces.	\$15 - on or before April 5 \$18 - after April 5	\$
<b>Arts &amp; Craft Vendor:</b> Handmade pet crafts/items. Commercially produced and imported goods will not be accepted in this category. Artists must submit photographs or images of your work (see above).	\$45 - on or before April 5 \$54 - after April 5	\$
<b>Service Vendor:</b> Any professional whose primary purpose is to provide an animal/pet related service. Service vendors may charge fees and/or distribute marketing materials.	\$110 - on or before April 5 \$132 - after April 5	\$
<b>Activity Vendor:</b> Any business/organization who provides an animal/pet related activity. Activity Vendors may charge fees for their activities. Activity vendors must provide proof of insurance (see below). Activity vendors may be approved for more than a 12' x 12' space.	\$125 - on or before April 5 \$150 - after April 5	\$
<b>Commercial/Retail Vendor:</b> For example, a business, enterprise, firm, company or other organization engaged in the trade of goods, services or both to consumers to make a profit for their company.	\$350 - on or before April 5 \$420 - after April 5	\$

**RELEASE** – The Applicant agrees to defend, indemnify and hold harmless The City, its agents, employees and officials, while acting within the scope of their duties, from all causes of action, demands and claims, including the cost of their defense, arising in favor of the Applicant, the Applicant's employees or third parties on account of personal injuries, bodily injuries, death, or damage to property arising out of the acts or omissions of the Applicant, its employees or representatives, concessionaires of the event or any other person or entity, except for liability caused due to the sole negligence of the City.
